# ADDITIONAL NOTES TO CONTRACT

- 9. If this agreement is cancelled by the management for any reason apart from the usual rules of "force majeur" the management will inform the agent immediately by telephone and confirm by fax or email.
- 10. Cancellation by the management may be accepted at the discretion of Alan Bearman Music and the artist but may incur an administration charge of 15%. Cancellation less than 60 days before the event will result in 50% of the fee being charged. Cancellation less than 30 days before the event will result in the full fee being charged.
- 11. The Artists agree that if they cannot perform because of illness, they will inform the management immediately and provide a medical certificate if required.
- 12. No reproduction or recording of the Artist's performance is permitted without prior consent.
- 13. An adequate secure dressing room will be provided for the artist's use.
- 14. All soundchecks must be completed in time to allow the artist to eat / relax before the performance.
- 15. Where a 'percentage of the door' deal has been agreed, ticket prices are not to be changed without the agent's written consent. If a percentage of the net income has been agreed there should be no increase in the venue costs to be deducted in such a transaction without prior agreement by the agent.
- 16. The management agrees to fully advertise and promote the engagement.
- 17. This contract is written formalisation of a binding agreement made verbally or by email. This agreement stands with the terms described in this written contract unless ABM is advised more than 60 days before the performance date that the management wishes to withdraw.
